**Open Meeting.**

Ms. Diane Williams called meeting to order at 6:00 P.M.

**Approval of Minutes.**

Mr. Eric Hayes moved to accept the minutes for January 26, 2010, seconded by Mr. Rueben Cuellar, unanimous vote for approval.

**Discuss/consider re-plat of Lots Fifteen (15) through Eighteen (18), Block Five-Hundred and Two (502), Velasco Townsite, into Lots Fifteen (115) and Sixteen (16), Velasco Townsite, to be known as 5 Broad Subdivision.**

The members discussed the re-plat and Ms. Joyce Adkins wanted to know why the re-plat was named 5 Broad Subdivision and if that meant that any house being built there was going to be named 5 Broad Subdivision also. Mr. Nat Hickey explained to the Board Members that the County required all re-plats to have a name and that it could not be filed with the County without one and that the owner of the property names their own re-plat.

Mr. Eric Hayes moved to accept the re-plat, seconded by Mr. Alonzo Martinez, unanimous vote for approval.

**Discuss/consider re-plat of Lots Seven (7) and Eight (8), Block One-Hundred and Ten (110), Freeport Townsite, to be known as Espinoza Subdivision.**

The members discussed the re-plat.

Mr. Eric Hayes moved to accept the re-plat, seconded by Mr. Alonzo Martinez, unanimous vote for approval.

**Discuss/consider truck route.**

Lt. Allen Lawson and the members discussed the truck route. Mr. Robert Marc Wilkerson addressed the Board Members with some concerns he had with the hazardous trucks that were driving out in Bridge Harbor. He stated that the trucks were traveling down the road at speeds that were taking a toll on the area resident's foundations. Lt. Allen Lawson stated to the residents that there was nothing that could be done about the trucks traveling out there since there was only one way in and out of there to get to those business' and that they have to travel off the truck route to get to their point of delivery. Ms. Williams suggested that the residents go to City Council and see if there couldn't be something done about the road being stabilized to reduce the impact that the trucks were having on the road.

**Send recommendation to City Council on truck route.**

Mr. Eric Hayes made motion to send the recommendation on the truck route to the City Council, seconded by Mr. Alonzo Martinez, unanimous vote for approval.
